1. What is this Double salary campaign all about?

3. I already have a Mashreq account; can I participate in this campaign?

Yes, you can participate in this campaign by transferring your salary to Mashreq account. Once you transfer salary to Mashreq account, you will automatically be enrolled in this campaign.

If you are already transferring salary to Mashreq, you will automatically be enrolled in this campaign.

4. How can I double my Salary?

You can do it in 2 ways:

1. If you have a Mashreq account, transfer your salary to Mashreq account. You will automatically be enrolled in this campaign as long as you transfer salary to Mashreq account before Nov 2020. But the sooner you transfer salary to Mashreq, the higher your chances of doubling your salary.
2. If you don't have a Mashreq account, just open a Mashreq account and transfer your salary to Mashreq account. You will automatically be enrolled in this campaign as long as you transfer salary to Mashreq account before Nov 2020. But the sooner you open account and transfer salary to Mashreq, the higher your chances of doubling your salary.
